No, the department has not identified inadequate portions but since the past 10-year plan was written additional statute have been passed related to broadband access which impacts the 10-year telecom plan.

Act 71 (H.360) from the 2021-2022 session was enacted since the 2021 Telecom Plan was adopted and this included several significant changes to state telecom planning statutes.

30 VSA 7515b states that it is the purpose of the Connectivity Initiative is to provide each service location in Vermont access to broadband that is capable of speeds of at least 100 Mbps symmetrical.
