VY Decommissioning Update

Dry Fuel Storage Project

- ISFSI Pad Construction
 - ➤ North Warehouse Removal Complete
 - ➤ All Waste (LLW) Shipped Off-Site Mid-December 2016
 - ➤ Construction restarted on March 13th, 2017

Holtec Cask System Fabrication

- > 8 MPCs scheduled to be delivered on or about March 27th
- ➤ 8 HI-STORMs scheduled to be delivered on or about May 22nd
- > 25 Casks are stored on pad 13 Loaded Casks & 12 Empty Casks

> 2017 Dry Fuel Loading Campaign

- ➤ Approximately 27 Dry Casks scheduled to be loaded in 2017
- 2017 Loading Campaign scheduled to commence in April 2017

Water Management



- Intrusion Water Disposition Plan
 - Intrusion water retention, shipment and removal plan continues to be implemented.
 - In-leakage prevention projects seeking to further reduce the intrusion of groundwater are ongoing.
 - A recent project to seal a crack in the TB structural mat is complete (2/23/17).
- EnergySolutions is providing shipment and disposal services
 - Groundwater is being shipped to EnergySolutions licensed disposal site in Tennessee.
 - Shipping one to two shipments per week at the present intrusion rate to minimize on-site storage.
 - A total of 493,000 gallons have been shipped to date.

Public Service Board Approval Process

- Entergy and NorthStar submitted their joint petition for approval and prefiled testimony from 8 witnesses in support of the transaction on December 16th, 2016.
- Scheduling Order issued by the PSB on February 8th, 2017
- Motions to Intervene deadline March 1st, 2017

 - Information Session hosted by VDPS 6:00 p.m.
 - Public Hearing hosted by the PSB 7:00 p.m.

NRC License Transfer Application Update

- NRC Pre-Submittal Public Meeting January 24th, 2017
- License Transfer Application (LTA) submitted to USNRC February 9th, 2017
- Revised Post-Shutdown Decommissioning Activities Report (PSDAR) targeted to be submitted by the end of March/early April
- Special NDCAP Meeting in Vermont Date TBD
 - NRC, NorthStar and Entergy invited to participate
 - Hosted by the NDCAP
 - Date will be informed by PSDAR submittal and a period of time for public review

Nuclear Decommissioning Trust Update

- ➤ The ENVY Nuclear Decommissioning Trust (NDT) balance was \$564 Million on January 31, 2017
- ➤ The NDT balance was \$571.5 Million on February 28, 2017
 - The increase was due to positive market performance, partially offset by reimbursements from the NDT. Fund expenses occur periodically throughout the year.
 - Summary of NDT Performance in 2017:
 - > \$6.0M in Qualified Withdrawals
 - > \$15.9M in Market Gains
 - > No Fund Expenses thus far in 2017
- ➤ The Site Restoration Trust balance was \$23.4 Million on February 28, 2017.
 - Entergy has funded \$20M to date; \$3.4M fund growth.
 - Final \$5M annual contribution to the Site Restoration Trust scheduled for December 2017.






