"SMUD supports this robust interim storage program that will save both taxpayers and ratepayers with a safe and far more efficient system for dealing with the nation's spent fuel. We urge support and swift passage of Rep. Matsui's thoughtful legislation."The Sacramento Municipal Utility District (SMUD) – Sacramento's public utility – stores spent nuclear fuel at the site of Rancho Seco Nuclear Generating Station, which SMUD operated until 1989. SMUD spends approximately \$5 million annually maintaining the spent fuel, but the federal government has a statutory responsibility to store the material. Matsui's legislation would, if enacted and exercised by the Secretary of Energy, provide a path to move spent nuclear fuel and lead to the elimination of these costs.
