STATE NOTES: Alabama - check to confirm residential. Website for ADECA was down. 22 counties do not adopt residential codes??

Alaska - Housing that is financed is covered by these codes. Non-financed housing is not covered by codes except in some cities. Same true w commercial?

Arizona - The only county that does not have a code is Greenlee, population 9,000.

Arkansas -confirm enforcement is statewide. One document implies it's optional.

Colorado - Just passed a statewide energy code. It appears 11 counties do not have building codes.

Delaware - Adoption is optional, but every county has adopted the building code.

Hawaii -- confirm counties have to enforce. Not clear.

Idaho - It appears 6 counties do not have building codes.

Illinois - State website makes the code seem mandatory. But one website says many towns do not.

Iowa - has 3 state building inspectors to cover places there is no local official.

Indiana - local enforcement; 4 default state inspectors for counties that do not administer.

Kansas - many counties do not adopt building codes.

Kentucky - confirm local enforcement is optional.

Louisiana - municipalities must enforce. They may use 3rd party inspectors.

Maryland - confirm local adoption is mandatory.

Massahusetts - confirm state enforces via locals. No local adoption/enforcement right?

Michigan -- CONFIRM (1) building codes (2) energy codes are state adopted, mandatory enforcement

Mississippi - confirm all. Confirm IECC is mandatory. 2 counties do not adopt codes.

Missouri - 9 counties do not adopt codes.

Nebraska - State can enforce energy code if county does not.

Nevada - Statewide code; administered by county. Some counties have not adopted the energy code (but are supposed to...website may be out of date.

North Dakota - 10 sparsely populated counties do not have codes. 90% of the population lives in counties with codes.

Ohio - not clear. State codes but only guidance? All adoption and enforcement is local? Do all counties or cities enforce?

Oklahoma - "in most cases, in counties & cities where there is no enforcement, jurisdiction goes to the state fire marshal." CHECK.

Pennsylvania - 90% of all municipalities enforce locally. For towns that have opted out, the State inspects commercial. Residential owners must hire inspectors.

South Dakota - Confirm all fields w inspector. Websites do not agree.

Texas - At least 16 of 254 counties do not adopt building codes.

Utah - mandatory minimum state codes. Optional for towns to adopt; confirm all have adopted.

West Virginia - 7 counties have not adopted codes? Can they make their code more restrictive? Is the State the default if town does not adopt?

Wyoming - It appears 7 counties do not adopt building codes.
