- ▶ **Decommissioning Preparation Activities**
  - System Draining/Lay-Up (52 Systems/22 In Progress/7 Complete)
  - Building Power Removal to “Cold and Dark”
  - Security Modifications/Enhancements Ongoing
- ▶ **Completed Select Structure/Building Removal**
  - Seven (7) Structures Removed to Improve Security Plan
  - One (1) Interim Waste Storage Pad
- ▶ **Hostile Action Based (HAB) Graded Exercise – May 13, 2015**
  - Multi-Agency Involvement (NRC, FEMA, MEMA, NH-HSEM, VT-DEMHS)
  - Local Law Enforcement (LLE), State Police
  - Joint FEMA/NRC Exit Meeting on May 15, 2015 Communicated Results
  - Overall Performance was Excellent with all Objectives Met

# VY Decommissioning Update (Cont'd)

## ▶ Vermont State Agency Interactions

### ◦ Agency of Natural Resources (ANR)

- Issued a Request for Information (RFI) and Records to VY on March 6, 2015 as a follow-up to the Site Assessment Study (SAS) and recent work at the site.
  - Meeting held between VY and ANR on March 19, 2015 to discuss the RFI, seek clarification on certain questions.
  - Response to the RFI was provided to ANR on Friday, March 27, 2015.
  - A Supplemental Request for Information and Records letter was received on May 18, 2015 with a requested 14-day response.
- Representatives from the ANR Department of Environmental Conservation, Waste Management & Prevention Division conducted a site inspection and data review specific to hazardous material management on May 18, 2015
  - Minor issues with labeling, waste characterization and inventory records were noted and subsequently corrected.

# VY Decommissioning Update (Cont'd)

## ▶ Vermont State Agency Interactions

### ○ Department of Health (VDH)

- Issued a Request for Information (RFI) and Records to VY on April 2, 2015 regarding asbestos and lead control compliance.
  - Response to the RFI was provided to VDH on Wednesday, April 22, 2015 providing the requested information and to set-up a face-to-face meeting to discuss any questions. No response from VDH to date.

### ○ Public Service Board (PSB)

- A Status Conference was held before the PSB on April 29, 2015 to discuss Docket No. 8300 seeking a Certificate of Public Good (CPG) authorizing the construction of a 2<sup>nd</sup> ISFSI pad and related improvements including installation of a new 200 kW diesel generator.
- The PSB issued a Scheduling Order on May 6, 2015.
- Public Hearing will be conducted on June 4, 2015.
